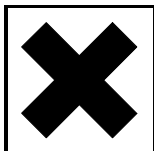

## SECTION 4: First aid measures

### 4.1 Description of first aid measures

**General** : In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person. If unconscious, place in recovery position and seek medical advice.
