4. First-Aid Measures

4.1 Symptoms

- Skin contact : There may be irritation and redness at the site of contact
- Eye contact : There may be pain and redness. The eyes may water profusely. There may be severe pain. The vision may become blurred. May cause permanent damage.
- Ingestion : There may be soreness and redness of the mouth and throat. Nausea and stomach pain may occur.
- Inhalation : There may be irritation of the throat with a feeling of tightness in the chest.

4.2 Actions

- Skin Contact : Remove all contaminated clothes and footwear immediately unless stuck to skin. Wash immediately with plenty of soap and water.
- Eye Contact : Bathe the eye with running water for 15 minutes. Transfer to hospital for specialist examination.
- Ingestion : Wash out mouth with water. Do not induce vomiting. If conscious, give half a litre of water to drink immediately. Consult a doctor.
- Inhalation : Remove casualty from exposure ensuring one's own safety whilst doing so.

5. Fire-Fighting Measures

- Extinguishing Media : Suitable extinguishing media for the surrounding fire should be used. Use water spray to cool containers.
- Exposure Hazards : In combustion emits toxic fumes.
- Protection of Fire-Fighters : Wear self-contained breathing apparatus. Wear protective clothing to prevent contact with skin and eyes.

6. Accidental Release Measures

- Personal Precautions : Mark out the contaminated area with signs and prevent access to unauthorised personnel. Do not attempt to take action without suitable protective clothing - see section 8 Of SDS. Turn leaking containers leak-side up to prevent the escape of liquid.
- Environmental Precautions : Do not discharge into drains and rivers. Contain the spillage using bunding.
- Clean-up Procedures : Absorb into dry earth or sand. Transfer to a closable, labelled salvage container for disposal by an appropriate method.

7. Handling and Storage

- Handling Requirements : Avoid direct contact with the substance. Ensure there is sufficient ventilation of the area. Avoid the formation or spread of mists in the air.
- Storage Conditions : Store in cool, well ventilated area. Keep container tightly closed.

8. Exposure Controls / Personal Protection

- Hazardous Ingredients : 2 – BUTOXYETHANOL
WEL (8 hr exposure limit): 25 ppm WEL (15 min exposure limit) : 50 ppm
- Engineering Measures : Ensure there is sufficient ventilation of the area.
- Respiratory Measures : Self-contained breathing apparatus must be available in case of emergency.
- Hand Protection : Protective gloves.
- Eye Protection : Tightly fitting safety goggles. Ensure eye bath is to hand.
- Skin Protection : Protective clothing
